

PHYSICIAN ASSISTANT MASTER'S PROGRAM

The Accreditation Review Commission on Education for the Physician Assistant (ARC-PA) has granted Accreditation-Continued status to the York College, CUNY Physician Assistant Program sponsored by the York College, CUNY Accreditation-Continued is an accreditation status granted when a currently accredited program is in compliance with the ARC-PA Standards. Accreditation remains in effect until the program closes or withdraws from the accreditation process or until accreditation is withdrawn for failure to comply with Standards. The approximate date for the next validation review of the program by ARC-PA will be April 2028. The review date is contingent upon continued compliance with Accreditation Standards and ARC-PA policy.

PROGRAM FACTS

Mission

The York College Physician Assistant program seeks to recruit and educate students from diverse surrounding communities to become highly competent, compassionate, and culturally aware providers of excellent medical care to underserved urban areas. Incorporated in our mission is a priority on increasing access to medical professional education for racial and ethnic minorities, financially disadvantaged students, and first-generation college graduates. Our program is committed to providing strong support so that we may also expect high performance from our students. All students successfully completing the program are eligible to sit for the national PA board examination administered by NCCPA and will have completed a didactic and clinical curriculum emphasizing urban medical care.

The Program's commitment to Diversity

The York College / CUNY PA program recognizes Equity, Diversity, and Inclusion (EDI) as essential elements for excellent patient care. The following goals were developed to assist the program in its EDI efforts.

1. Recruit and retain a student population reflecting the ethnic, racial, and linguistic diversity of CUNY, as well as exceed the national average of underrepresented minorities among physician assistant programs in the country.
2. Serve as an engine of social and economic mobility for financially disadvantaged students by maintaining an affordable tuition and fee structure of at least 10% lower than the national average.
3. Produce a graduating class with at least 80% committed to working in the NYC metro communities (5 boroughs of NYC, Long Island, Westchester, surrounding cities of New Jersey, and Connecticut) to help address the healthcare needs of these diverse communities.
4. Recruit and retain a diverse faculty and staff
5. Provide all students, faculty, and staff with the needed resources and tools to ensure their sense of inclusivity; and personal and professional development.

The Profession

Physician Assistants (PAs) are health professionals licensed to practice medicine with physician supervision. They are qualified by graduating from an accredited PA training program and obtaining certification from the National Commission on Certification of PAs (NCCPA). Certified PAs can then seek licensure from the state where they seek to practice medicine.

Within the collaborative physician-PA relationship, physician assistants exercise autonomy in medical decision-making and provide a broad range of diagnostic and therapeutic services. The clinical role of physician assistants includes primary and specialty care in medical and surgical settings working in both rural and urban areas. Physician Assistant practice is centered on patient care and may include educational, research, and administrative activities.

The Nature of the Work

The PA elicits medical histories, performs complete physical examinations, performs and interprets various diagnostic tests, and formulates diagnosis and treatment plans. The physician assistant functions within the supervising physician's scope of practice and the level of experience and training achieved. An important component of PA practice is patient counseling and patient education.

Physician Assistants practice in varied settings, including private medical offices, hospitals, clinics, and community health centers.

Physician Assistants practicing in New York State may write prescriptions for medications, including certain classes of controlled substances. Physician assistants provide services in various medical and surgical disciplines including, but not limited to family practice, pediatrics, internal medicine, obstetrics/gynecology, geriatrics, orthopedics, psychiatry, and emergency medicine. The physician assistant role requires the application of intelligence, compassion, sound judgment, critical reasoning, dedication to patients, and good interpersonal skills.

The PA Program at York

The PA Master's Program at York College has been designed as a 28-month upper-division program, requiring a bachelor's degree with prerequisite coursework. All graduates are awarded a Master of Science degree in Physician Assistant Studies (MSPAS). The current PA Program at York College is a full-time, daytime, 28-month program that commences every fall. The first five semesters (Fall, Winter, Spring, Summer, and Fall) are didactic and are mainly conducted in the Physician Assistant Program classrooms located in the York College Science Building, rooms SC113 and SC131. Schedules are generally 9 AM to 5 PM Mondays through Fridays, but may vary. The remaining four semesters (Winter, Spring, Summer, and Fall) are spent on clinical rotations at several assigned medical facilities consisting of hospitals and clinics. During clinical rotations, students may be "on-call", requiring an overnight stay at the clinical site. Students are required to follow the schedule assigned to them by the clinical site supervisor.

ADMISSIONS REQUIREMENTS

Open Houses/Information Sessions - Current York students and transfer students are strongly encouraged to attend an information session. Contact the program's admissions coordinator for more information on scheduled information sessions. You can also check the York College website for upcoming Open Houses.

Step 1: Determine Eligibility for Application:

1. Completion of a bachelor's degree with a cumulative GPA of 3.0 or higher
2. Grade Point Average (GPA) of 3.0 minimum in the following 2 categories:

Science Prerequisites

- One Year of General Biology with Laboratory (Bio 201, 202)
- One Year of Human Anatomy & Physiology with Laboratory (Bio 234, 235)
- One Semester of Microbiology without Laboratory (Bio 265 or Bio 465)
- One Year of General Chemistry with Laboratory (Chem 108, 109, 111, 112)
- One Semester of Biochemistry without Laboratory (Chem 412, Chem 460, or Bio 412)

Please note: the above science prerequisites can only be repeated once.

Courses with grades of "W" (withdrawal) will not be counted as a repeated attempt and, therefore, will not be included in the GPA calculation.

Overall Cumulative GPA (CUM GPA)

- All College-Level Work, including Post-Baccalaureate, Graduate, and Professional Programs

No grade below a "C" in any prerequisite course will be considered

Please note the following:

- Students with a PA Program Science Prerequisite GPA of 3.0. or better, and whose Cumulative GPA is less than 3.0, may petition the Admissions Committee to be considered if they have evidence of consistent improvement in the last sixty credits. Consistent improvement is defined as a cumulative GPA of at least 3.0, calculated using grades for the last sixty credits taken. If you meet both these criteria (PA Program Science Prerequisite GPA of 3.0 and CUM GPA of 3.0 or better with the most recent sixty credits), you may submit a letter to the PA Program (paprogram@york.cuny.edu) explaining the initial performance and subsequent improvement, along with your most current transcript. If the petition is accepted, the maximum CUM GPA will be 3.0.
- In order to satisfy the behavioral science prerequisite requirement, you **must** have taken one semester of psychology and one semester of any one of the following: another psychology course or sociology or anthropology. There is no time restriction on these courses.
- The Human Anatomy & Physiology and Microbiology courses must be completed within five (**5**) years of enrollment.
- Other Science prerequisite courses (Biology, Chemistry, and Biochemistry) and Statistics must be completed within ten (**10**) years of enrollment. Courses completed outside of this window

will not be accepted and must be repeated.

- As an alternative to repeating the General Biology OR General Chemistry courses, applicants may demonstrate adequate content knowledge by successful completion of the CLEP (College Level Equivalency Placement) Exam. <https://clep.collegeboard.org/exam>. If an applicant has taken and passed the USMLE Step 1 within the last five years, they can be waived from repeating any outdated science prerequisites (**EXCEPT** Human Anatomy & Physiology I & II, and Microbiology).
- If an applicant has taken advanced placement (AP) chemistry and/or biology courses in high school, within **10** years of enrollment, those scores can be used to fulfill the general biology and/or general chemistry requirements. (**Expired science prerequisites are still factored into the cumulative GPA**)
- Science prerequisites completed greater than the allowed 10-year period of enrollment will not be used in the science prerequisite GPA calculations. However, for any repeated science prerequisite course completed within the 10-year period of enrollment, both grades will be used in the science prerequisite GPA calculations. The average of both grades for any repeated science prerequisite course completed within the 10-year period of enrollment will be calculated and serve as the final GPA for that course.
- For the Human Anatomy & Physiology I & II courses and Microbiology courses, earned grades of C+ and below will not be accepted. In the event these courses are repeated, the average of both attempts must be at least a "B -" (or GPA of 2.7).
- CUM GPA will be calculated using all courses regardless of timeline or when it was completed.

Upon applying to CASPA, you can have up to 3 PA program prerequisite courses pending. Pending courses may include 1 science course or Statistics course, **not both**, along with one or both behavioral science courses and any other courses needed for a baccalaureate degree. All pending courses must be completed by July 31st, prior to your enrollment in the fall semester.

Sequences for pending prerequisite courses for the PA Master's Program

Sequence I: One science prerequisite and one or both behavioral science prerequisites

OR

Sequence II: Statistics and one or both behavioral science prerequisites

3. Completion of at least 750 hours of Patient Care Experience (PCE) in a healthcare environment, either volunteer or paid.

Note: While at least **750** PCE hours are required for admission to the program, a **minimum of 500 hours must be completed and documented at the time of application**. Of this, at least **250** PCE hours must be completed within the last three years.

A separate letter on letterhead must be uploaded to CASPA as proof of healthcare experience, including contact information for your source.

Examples and Verification of Patient Care Experience: This should be a SEPARATE letter from any of the reference/recommendation letters. PCE means that the experience must be in a

direct patient healthcare environment and should occur within a licensed healthcare facility (organization). The experience must be related to patient management.

Examples of **acceptable** PCE include EMTs, Paramedics, Medical Assistants, Medical Scribes, Emergency Room Technicians, Nurses, Nurse Aides, Patient Care Associates (Technicians), Allied Health Professionals, etc. Shadowing a PA is also highly recommended.

Examples of **unacceptable** forms of health care hours include Receptionist, Clerical Work, Medical Salesperson, Home Health Aide, Direct Support Professional, caring for a relative or friend, virtual shadowing hours, PCE limited to only shadowing a PA/Physician, etc.

If you believe that your healthcare experience qualifies as a direct PCE, as described above, you may submit a maximum of a 150-word response for consideration.

Verification of healthcare hours is a requirement for the York College, CUNY PA Program. Although CASPA will deem your application complete without verification of your healthcare hours, without it, your application will be denied. Verification of healthcare hours can include a letter from the human resources department, a supervisor, a health professional being shadowed, or an administrator. However, it must be on the letterhead of the organization or individual, clearly stating hours and tasks performed, and must provide a contact number. Timesheets, pay stubs, and work schedule printouts are all unacceptable forms of documentation of health care experience.

Step 2: Upload Application and Supporting Documents

1. PA Program Application via CASPA (Central Application Service for Physician Assistants)

Please follow all instructions and upload all necessary documents listed below to CASPA's website. [This application is separate and in addition to the York College/CUNY application.]

Note: **A VERIFIED application has to be on file with CASPA NO LATER THAN December 1st**

2. Current Resume

3. Official Transcripts: All applicants must request to have their official transcripts from all colleges attended, including all CUNY schools, sent to CASPA's website.

4. Three Reference Letters (3 separate sources): Preferred sources include professors, health care professionals, and employers. Please upload **original** letters presented on professional letterheads Reference letters uploaded to CASPA must contain the contact number of the reference source.

5. Personal Statement. Please follow the instructions on the CASPA website.

6. Applying to York College: Applicants invited for an interview will be required to apply to York College before their interview.

Before an interview can be scheduled, a processing fee (currently \$75), must be paid to York College. Instructions on how to pay this fee will be provided at that time.

* *It is the applicant's responsibility to upload all required documents to CASPA's website. The PA Program faculty/staff are not responsible for obtaining any missing documents. You may contact the PA Program to track your application status. The PA Program also does not accept any hard copies of supporting documents. All supporting documents must be submitted through CASPA's website!*

Bonus Points

The program gives bonus points to applicants who have taken and passed at least three (3) or more credit hours at York College. The program also gives bonus points to applicants who have taken and passed at least 24 credits of courses at any one of the CUNY schools. E-permit courses can only be counted towards your home school credits. If you have ever served in the military, you can also receive Bonus points as a veteran. If you think you qualify, you will need to show proof that you are eligible to receive the bonus points.

International Students

Applicants from countries where English is not the primary language, or those who obtained a degree from such a country, are required to submit TOEFL scores. While individual program requirements vary, competitive applicants typically score at least a 4.0 on the new 1–6 band scale (equivalent to a 75 on the previous 0–120 scale). Please note that TOEFL scores are valid for two years from the date of the examination.

All foreign applicants must have their foreign transcripts evaluated by “[The Evaluation Company](#)” (TEC), formerly known as SpanTran. TEC has created a [custom application for York College](#) for the York College PA Program, which can be accessed at: <https://spanside.my.salesforce-sites.com/SpantranApplication>.

The program also accepts evaluation from the “[World Education Services](#)” (WES), if you prefer. Once your transcript has been evaluated, you must contact our **Admissions Coordinator, Ms. Tenesha Spain**, at tspain@york.cuny.edu.

The PA Program does not accept any transfer credits from foreign transcripts. All PA Program prerequisites must be taken and completed at an accredited college in the United States. All international students must complete at least 500 of the 750 healthcare experience hours in the United States.

Advanced Standing

There is no advanced standing in the program, regardless of the qualifications or experience of the applicant. All candidates must complete the entire 28-month course of study.

Additional Information

- You do not have to apply to York College until you are invited for an interview. Therefore, if you are not selected for an interview, you will not be asked to apply to York College.
- Admission to the Physician Assistant Program is competitive, and applicants may be placed on a waiting list or denied even if all requirements for screening are complete.
- An interview before the admissions committee does not guarantee admission into the program.

Required Technical Standards for Admission & Retention

The following technical standards for admission and retention establish the essential mental and physical abilities required for the successful completion of the York College Physician Assistant Program and for entry into professional PA practice.

All students admitted to the York College Physician Assistant Program are expected to be able to perform the tasks listed, with or without reasonable accommodation. York College offers a variety of services, activities, and accommodations to students with disabilities, mainly through the [Centers for Students with Disabilities](#).

Required Skills and Attributes

Intellectual-Conceptual, Integrative, and Quantitative Abilities: PA students must be able to sustain attention, reason, analyze, and learn a large amount of complex information. Information from various disciplines and sources must be correlated, and concepts must be applied to develop therapeutic plans and solve clinical problems in a timely fashion. The ability to extract valid, useful, and relevant information from medical literature is also required.

Observation and Sensory Functions: Students must be able to observe accurately in lecture, laboratory, and clinical patient care settings. They must have adequate sensory skills (including vision, hearing, and tactile sensation) to elicit medical histories and perform complete physical examinations utilizing inspection, percussion, palpation, and auscultation.

Communication Skills: Students must be able to communicate with patients in a sensitive manner and record and communicate patient information in a timely and effective manner to all members of the healthcare team. This includes the ability to perceive nonverbal communications and describe changes in mood, activity, and posture.

Motor and Neuromuscular Control: Students must have adequate neuromuscular control to perform therapeutic and diagnostic procedures (such as blood drawing, suturing, and casting), respond to emergency situations, and move about various healthcare environments. The didactic phase requires extended sitting, while the clinical phase requires extended standing and physical movement within clinical facilities.

Behavioral and Social Attributes: Students must maintain the emotional health required for the full utilization of their intellectual abilities and the exercise of good judgment. They must be able to relate to patients and colleagues professionally, maintain composure during periods of high stress, and respond appropriately to emergencies.

Inquiries and Accommodations

Requests for Accommodation: All accommodation requests are voluntary and must be made in writing prior to beginning coursework. Every effort is made to provide reasonable accommodation to students with documented disabilities.

Confidentiality: All information regarding disabilities is handled with strict confidentiality.

Consistency: These standards are consistently applied to all applicants and enrolled students and are maintained in the Physician Assistant Program [Didactic Student Handbook](#).

The Selection Process

The Physician Assistant Program uses a holistic approach in selecting candidates.

The factors considered in the holistic admissions process include:

1. The applicant's full record of academic achievement in college, including the number and rigor of courses taken and grades earned in those courses.
2. Professional preparations for the PA program such as employment as a healthcare worker, patient contact, work with underserved populations, and volunteering and shadowing experience.
3. Strength of letters of recommendation.
4. Personal statement including elements of style, creativity, originality, and anticipated goals as a Physician Assistant.
5. Alignment with the program mission.

Each application is evaluated using these criteria to determine eligibility for an interview. Race, ethnicity, gender, and religion are excluded from the selection criteria. The interview assesses the applicant's deductive reasoning, professionalism, disposition for the profession, problem-solving skills, verbal and non-verbal communication skills, and alignment with the program's mission. To ensure that our admission practices are consistently applied in accordance with ARC-PA Standard A3.13a, the program utilizes a weighted point system that recognizes mission-aligned attributes. Preference is given to candidates who are first-generation college students, veterans, NYC Metro area residents, CUNY students/alumni, or those from financially disadvantaged backgrounds (as defined by CASPA Economically Disadvantaged Indicator). Following this consistent preliminary review, selected applicants are invited for a formal interview to assess suitability for the profession and the program.

PA Credentials

1. A Master of Science in Physician Assistant Studies (MSPAS) is conferred when the Physician Assistant Program requirements are fulfilled, including successful completion of all Physician Assistant Major Discipline requirements, in addition to all prerequisite requirements.
2. Certification: Upon completion of all requirements and approval by the PA program, the graduate is permitted to sit for the National Commission on Certification of Physician Assistants examination. No separate certificate is issued.
3. Licensure: Upon completion of all requirements, the graduate may apply to New York State for limited permit licensure as a physician assistant. The PA can apply for a full license upon taking and passing the National Commission on Certification of Physician Assistants (NCCPA) examination. As state laws are constantly changing, please refer to the State's licensing board website for more details (<https://www.op.nysesd.gov/physician-assistants>).

OUTSIDE EMPLOYMENT POLICY

Applicants to the Physician Assistant program must assess their ability to pay tuition, equipment expenses, book expenses, travel expenses, and other living expenses for themselves and their dependents for the full 28 months of the program. The program is rigorous, and students need to be aware of the reasons why **outside employment is strongly discouraged while attending the PA program:**

- Class and rotation schedules are subject to change on short notice.
- Classes are typically scheduled between 9 AM and 5 PM but may be scheduled earlier or later.
- Clinical rotations may require weekend or evening/overnight work.
- The small amount of free time PA students have is usually solely needed for study, rest, or recreation
- No accommodation is made in schedules or attendance policy for outside employment
- Students will not be allowed to rotate at a clinical site where they were employed to avoid any conflict of interest
- No consideration will be made for academic difficulties secondary to deficient preparation because of outside employment

The program also strongly discourages enrollment in any work-study program while attending the PA program.

Please note that prospective or current PA students are not required to provide or solicit clinical sites or preceptors for the program.

Notice to Students on Criminal Background Checks

Current laws generally permit a state licensing board or agency to deny a license to practice if the applicant has been convicted of a felony or other specified crime. Like many state licensing boards, the Office of the Professions of the New York State Education Department requires that a criminal background check be conducted prior to granting a license.

The Department of Health Professions at York College does not require a criminal background check for admission to our degree program, but the Department's educational requirements include placement at one or more hospitals or other off-campus clinical training sites, and these sites frequently require a student to undergo a criminal background check before the student can be placed for clinical training. If, based on the results of a criminal background check, the site determines that a student's participation in its clinical training program would not be in the best interest of the site, the site may deny that student admission to the training program. Even if the student has already begun the placement when the results are received, the site may elect to dismiss the student, regardless of the student's performance while in the training program. Each clinical training site that requires a criminal background check sets its own standards and procedures, and you may be asked by the site to pay the cost of the background check. You may also have to complete more than one criminal background check during the course of the Health Professions at York College, depending on the number of sites where you are placed and the requirements of each site.

Some clinical rotation sites may also require that students submit to a drug test as a condition of their participation. Students will be responsible for the cost of this testing. Refusal to have a test may result in an inability to complete the rotation and possibly the professional program.

Please note that if a clinical training site determines that you may not take part in its training program based on the results of a criminal background check or drug test (or due to refusal to submit to a drug test), you may be unable to complete your course requirements and to continue in the Physician Assistant Program. It is important for you to be aware of these requirements and consider them before enrolling in a program offered by the Department of Health Professions at York College, as York College has no obligation to refund your tuition or fees or to otherwise accommodate you in the event you are ineligible to complete your course requirements based on the results of a criminal background check, or if you are denied a license to practice.

Frequently Asked Questions

Q: *When does the program begin, and how many students are accepted yearly?*

A: The program begins every Fall Semester, and we accept a maximum of 30 students per year.

Q: *How do I apply to the program?*

A: The York College PA Master's Program application can be found on CASPA's (Central Application Service for Physician Assistants) website caspa.cas.myliason.com.

Q: *Apart from the CASPA costs, are there additional fees required by York College?*

A: Yes. Once you have been selected for an interview, you will be asked to pay a \$75 York College processing fee. This must be completed before an interview can be scheduled. If you are transferring from another CUNY campus, a CUNY Transfer fee of approximately \$70 may apply. If accepted into the program, a commitment deposit of \$250 is required, which will be applied to your tuition once matriculated.

Q: *When does the program begin to accept applications and supporting documents?*

A: For the 2026-2027 cycle, prospective students may begin submitting their applications and uploading their documents to CASPA's website approximately April 25, 2026.

Q: *When is the application deadline?*

A: December 1st. Applications must be verified by CASPA by 11:59 ET on December 1st.
To ensure an application is verified on time, the application should be completed at least four weeks before the deadline

Q: *Can I attend the program part-time?*

A: No. The Physician Assistant Program is a full-time, 28-month program. There are no part-time evening or weekend classes.

Q: *Can I upload my application and supporting documents to CASPA's website before I apply to York?*

A: Yes, that is the policy

Q: *What is the cost of the program?*

Q: Do you offer student loans?

Q: Does the PA Program offer any scholarships?

A: No. However, the college may have options available. You can check with the college's scholarship office at Scholarships@york.cuny.edu or visit the scholarship center at: <https://www.york.cuny.edu/scholarship>.

Q: Do you have clinical sites where I can acquire hours of healthcare experience?

A: For a list of potential sites, see pages 16 and 17 of the PA Admission Brochure (this brochure).

Q: Does the program accept virtual shadowing hours as a healthcare experience?

A: No. Virtual healthcare hours are not accepted.

Q: Do I have to complete all the prerequisites before applying to the program?

A: No, you may be in the process of completing one (1) science prerequisite or statistics, not both. You may also be in the process of completing the behavioral science prerequisites and courses to complete a bachelor's degree. You must complete all the prerequisites and obtain a bachelor's degree before July 31st, the year that you will enroll in the program.

Q: Are online courses satisfactory for your prerequisite requirements?

A: Yes, if the online courses are from a U.S.-based accredited academic institution of higher learning.

Q: Do you accept statistics courses other than regular statistics, for example, biostatistics?

A: Yes, however, the program may need to review the course description for approval. If you are unsure whether your course is acceptable, you can send us your course description via email to pacoursereview@york.cuny.edu. The course will be reviewed, and you will be notified of the outcome.

Q: Do you accept any type of psychology course to fulfill the psychology prerequisite requirement?

A: Yes

Q: Does the program accept transfer courses from professional or medical programs?

A: No, the PA Program does not grant advanced standing, transfer credit, or credit for prior experiential learning. All students must complete the full curriculum regardless of previous experience.

Q: *If I completed the didactic year of a PA Program at a different school; would your program accept my PA Program courses?*

A: No. The program does not accept any course(s) completed at another PA program.

Q: *I took organic chemistry and did not realize I had to take biochemistry. Can I substitute organic chemistry for biochemistry?*

A: No, the program does not allow any substitutions for any of the science prerequisite courses.

Q: *Will all the science courses I have taken be included in my science GPA?*

A: No, only the PA Program's eight (8) science prerequisite courses, including all repeats and expired science prerequisite courses.

Q: *Is the GRE required for this PA Program?*

A: No. The program does not use the GRE or any other standardized testing when making admission decisions.

Q: *Does the program accept pass/fail grades for the science prerequisites?*

A: No. However, an exception is for courses taken during the COVID-19 Pandemic period, which include the courses that were taken during the Spring 2020, Fall 2020, or Spring 2021 semesters.

Q: *What is the average science GPA for applicants?*

A: The program's 5-year average Science GPA for accepted students is 3.64.

Q: *What is the average number of Healthcare hours for applicants?*

A: The program's 5-year average patient care experience (PCE) hours for accepted students is 2560.

Q: *How many times can an applicant apply to our PA Program?*

A: Twice. However, applicants considering applying for the third time must submit a petition before applying. This requires a formal letter addressed to the admission committee and emailed to paprogram@york.cuny.edu.

Q: At what point during the admission cycle are acceptance letters sent out?

A: The program operates on a rolling admission basis. Applications are continually being reviewed, and decisions are being made throughout the process.

Q: Can you be accepted into the PA Program if you are not a citizen or permanent resident of the United States?

A: Yes. The York College PA Program does not exclude students based on immigration status. Students eligible for acceptance to CUNY are eligible to apply. However, because PA students rotate at clinical sites that require background checks and would need to obtain licensure before being able to practice medicine, appropriate and valid documents may be required for such purposes.

Q: Can you take the certification exam if you are not a citizen or permanent resident of the United States?

A: Yes. You may be eligible to sit for the exam if you graduate from an accredited Physician Assistant Program and meet all other requirements set forth by the certifying agency. You can get additional information by visiting NCCPA's website at <https://www.nccpa.net>

Q: Can you work or practice as a Physician Assistant if you are not a citizen or permanent resident of the United States?

A: Yes. State law requirements vary. It is strongly encouraged to seek legal help on such matters. The CUNY Citizenship Now office may also be helpful:

Q: Does the York College, CUNY PA program prefer certain types of applicants?

A: The program does not discriminate among applicants. It uses a holistic selection process to attract and recruit applicants consistent with its mission. See page nine (9) of the PA Admission Brochure (this brochure) for additional details about our selection criteria.

Q: What type of college degree will I acquire after I graduate from the program?

A: Students who graduate from the PA program receive a Master of Science degree in Physician Assistant Studies (MSPAS).

Q: Can students who graduate with their BS in Physician Assistant Studies at York come back to complete the MS program?

A: No, this will not be possible since, with the transition to a graduate degree, many of the PA courses offered for the BS will also be offered for the MS program.

Q: Can I update my application after it has been verified by CASPA?

A: Yes, you can update your application until the current CASPA cycle closes in March.

Please note: While the program conducts interviews on a rolling basis, interviews for the Fall class may continue in the preceding Fall into the Spring semester. Applicants who have submitted a completed, verified application, all required documentation, and meet all the criteria for an interview will be called first. The program currently admits a maximum of 30 students per year, and interviews will continue until the program officials deem it necessary. Every attempt will be made to notify candidates by March 31st.
